Note 1:

Excerpt from Angus Council Scheme for the Establishment of Community Councils Section 7.1:

- (iii) Any individual who is elected to serve on Angus Council, or a person appointed to a committee of the Council in terms of Section 57 of the [Representation of the People] Act 1973 or a person who is elected to serve on the Scottish, UK or European Parliament shall be ineligible to stand for election or co-opted to a Community Council."
- (iv) Any individual who holds a politically restricted post in terms of the Local Government and Housing Act 1989, as amended by the Local Governance (Scotland) Act 2004, and by the Local Government (Political Restrictions) Regulations 1990 shall be ineligible to stand for election or co-opted to a community council.
